From the information provded we then use that information to inform relevant affiliated socities that the show is affiliated to of results.

Local and National Press of results

We may share this information with relevant authorites if we receive a request in writing.

### HOW WE GET THE INFORMATION AND WHY DO WE HAVE IT

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- Exhibitor at the Show
- Trade Stand at the Show
- Sponsor at the Show
- Advertiser at the Show

We also receive personal information indirectly, from the following sources in the following scenarios:

- Exhibitors Entry Form
- Membership to the show
- Trade Stands Applications
- Sponsors od classes etc
- Advertisers main Show Day Catalogue
- Contractors providing a service to the show and are contracted by the Committee.

All the information is provided on the show's offical application forms which can be downloaded from our website <a href="https://www.stclearsyfcshow.co.uk">www.stclearsyfcshow.co.uk</a>

We collected this date for the **SOLE USE** of the Show Committee and its officals, and all information collected is held by the Show Secretary. Information is collected for the sole use of committee to collect relevant results (a) Section winners (2) Silverware Winners, to be used in the following year's show. By having this data we are able to make contact with regards to Silverware won at any previous show. We as a show committee do not share this information with anyone else. Your details are then stored in a secured cabinet.

We collect personal information because we have a legal obligation to do so. As an exhibitor, advertisor, sponsor, member we will hold this data for a maximum of 3 years and then the information stored securly and will be properly destroyed at the end of the 3 years

You can at any time make a written request to remove any information that we have on you from our storage. Please make full representation in writing to the General Show Secretary whose information can be found at the start of this document

#### WHAT WE DO WITH THE INFORMATION

The information we hold is only used by the Show Committee to update it's records on exhibits at the show and to also inform the relevant Socieites that the show is affiliated to of winners. This information can be lifted on the show web page of current year winners.

We do not share your information with any other show or business. No information is shared with businesses outside of the EU.

We do note that should the need arise, regulated authorities have the right to ask for information eg – Police, Local Government, Welsh Government etc. Should and only should this arise then we will inform you of this prior to information being share.

# GENERAL DATA PROTECTION REGULATIONS (GDPR)

- (A) Your consent. You are able to remove your consent at any time. You can do this by contacting the General Secretary as per details under **OUR CONTACT DETAILS**
- (B) We have a contractual Obligations
- (C) We have a legal obligation.
- (D) We have a vital interest.
- (E) We need it to perform a public task eg Show results in local papers, results with affiliated socities.
- (F) We have a legitimate interest

## YOUR DATA PROTECTION RIGHTS

Under the Data Protection Law you have the following rights:-

- ❖ Your right to access You have the right to ask us for copies of your personal information
- ❖ Your right to rectification You have the right to ask us to rectify infromation you think is inaccurate. You also have the right to ask us to complete information you think is incomplete
- ❖ Your right to erasure You have the right to ask us to erase your personalinformation in certain circumstances.
- ❖ Your right to striction of processing You have the right to as ask us to restrict the processing of your infromation in certain circumstances.
- ❖ Your right to data portability You have the right to ask that we transfer the information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
